**Note to Section A:**

**B. Covered Goods and Services**

1. Goods

Chapter 11 applies to all goods procured by entities listed in Section A, except where Brunei considers it necessary to take measures for the protection of its essential security interests relating to the procurement of arms, ammunition or war materials, or to procurement indispensable for national security or national defence purposes by the Internal Security Department, the Royal Brunei Police Forces, the Royal Brunei Armed Forces or the Prison Department.

2. Services

Chapter 11 applies to all services procured by entities listed in Section A, except where Brunei considers it necessary to take measures for the protection of its essential security interests relating to the procurement of arms, ammunition or war materials, or to procurement indispensable for national security or national defence purposes by the Internal Security Department, the Royal Brunei Police Forces, the Royal Brunei Armed Forces or the Prison Department.

3. Construction Services

Chapter 11 applies to all construction services procured by entities listed in Section A, except where Brunei considers it necessary to take measures for the protection of its essential security interests relating to the procurement of arms, ammunition or war materials, or to procurement indispensable for national security or national defence purposes by the Internal Security Department, the Royal Brunei Police Forces, the Royal Brunei Armed Forces or the Prison Department.
