Condition of Tender

1. Each Tenderer shall for each Tender it submits, maintain a Validity Period of **six (6) months** from the Tender Closing Date. Any Tender expressed to be valid for a shorter period, may, in absolute discretion of the Government, be rejected.
2. Where the Government seeks an extension of the Validity Period, a request in writing will be forwarded to the Tenderer. The Tenderer shall be required to respond in writing to extend the Validity Period. Failure to respond will result in the Tender not being considered further.
3. Tenderers are required to make a declaration in the form provided – **(Declaration Form attached)**. The Purpose of the declaration is to prevent incidences of collusion among potential Tenderers to this Invitation To Tender.
4. In the event any Tenderer is found to have colluded with another Tenderer or Tenderers in this Invitation To Tender, the Government reserves the right to disqualify any or all Tenderers involved in such collusion which decision shall be at the Government's absolute discretion.
5. Tenderers are required to submit their Company's Certificate of Incorporation or Firm's Certificate of Registration, as applicable, with their Tender.

Sections 182 of the Penal Code (Cap 22 of the Laws of Brunei)

182. Whoever gives to any public servant any information which he knows or believes to be false, intending thereby to cause, or knowing it likely that he will thereby cause, such public servant;

- (a) to do or omit anything which such public servant ought not do or omit if the true state of acts respecting which such information is given were known by him; or
- (b) to use the lawful power of such public officer to the injury or annoyance of any person, shall be punished with imprisonment of either description for a term which may extend to 6 months, or with fine which may extend to \$4,000.00, or with both.
